PERMIT SUBMITTAL REQUIREMENTS

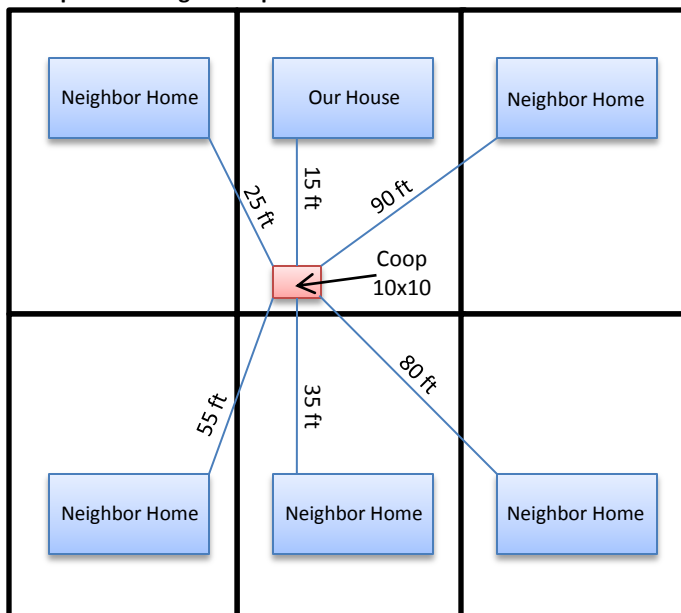
Requirements for submittal vary depending on the type of permit.

Developments/Buildings/Utilities: A permit for any structure, development, or utilities require a site plan, plat, or building/facility design as required by code regarding subdividing or building.

Animals: A permit for any animal use requires a management area plan. The plan can be hand drawn. The management plan shall include:

- Drawing of lot and adjacent lots where the animal use will occur.
- Dimensions of animal pin, coop, coral, or other living areas.
- Setbacks from animal area to any structures on the property or adjacent lots.
- Feeding area.
- Written description of how the animal, living area, coop, and feeding area will be maintained, how other animals will be kept out, and how odors and other potential nuisance will be controlled.

Example of management plan



1. Feed area shall be within the coop
2. Coop and feeding area will be maintained by weekly cleaning of feces.
3. Feeding area and coop are covered to keep other animals out.
4. Cleaning the feces weekly should control odor.
5. Chickens shall be allowed to roam the yard area to control grasshoppers and to help fertilize the garden.

NOTABLE CONSIDERATIONS

1. Conditional use permits are approved/denied by the planning commission.
2. The commission meets on the 2nd and 4th Thursdays at 7pm.
3. Planning commission can require additional information or set conditions on their approval to mitigate any adverse effects of the proposed use.
4. Concept plans for developments are required.
5. Site plans for buildings and utilities are required.
6. Site plan or livestock management area plan for animal uses showing locations of pins/coops/corral etc. is required.
