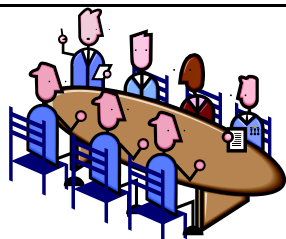

📁 **Application Paperwork/Plats** - Application for subdivision, conditional use permit, zoning changes, General Plan amendments, etc. must be received along with applicable filing fees. Also all written proof of utilities; water, power, gas, perk tests, Health Department approval, telephone, and UDOT if applicable, along with any other written documentation that is required for petition; i.e. homeowner's associations, etc., description of business or petitioned use. **Please call Tamara Wright at 435-734-3316 to schedule an appointment to turn in your application.**

All applications need to be submitted by appointment with the County Planner for review before being accepted. Any petition that does not include all required paperwork by the above outlined deadlines, WILL NOT be placed on the Planning Commission agenda.

📁 Notices of Public Hearings regarding subdivisions, re-zones, changes in the Code and Conditional Use Permits are required by law and must be noticed in the local newspapers ten (10) days prior to the Planning Commission meeting, which has necessitated the change in the submission deadline for petitions.

There is always the possibility that a planning meeting may be cancelled due to Holidays during a particular month (particularly July, November, December and January). If this happens, the Planning Office will make every attempt to notify the public of that decision.
