

159-ORDINANCE NO. 2007-15

AN ORDINANCE AMENDING A PORTION OF TITLE 6 OF THE TOWN OF ALPINE MUNICIPAL CODE, PERMITTING WATER FRANCHISES WITHIN THE TOWN LIMITS UPON THE APPROVAL OF THE TOWN COUNCIL, AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF ALPINE, WYOMING THAT:

Section I. Amendments to Sections 6-3 and 6-4.

(a) Title 6, Section 3 of the Town of Alpine Municipal Code is hereby amended by deleting it in its entirety and inserting a new Title 6, Section 3, which reads as follows:

6-3 Water supplier – Franchise not granted when. No person, firm or corporation shall be granted any franchise or permit to furnish or supply any inhabitant within the Town any water for domestic or culinary use or for the sprinkling of lawns and gardens within any portion of the Town where the water mains have been extended or may hereafter be extended so as to supply the property with water, except upon the approval of the Town Council.

(b) Title 6, Section 4 of the Town of Alpine Municipal Code is hereby amended by deleting it in its entirety and inserting a new Title 6, Section 4, which reads as follows:

6-4 Exclusive Water System. It shall be unlawful for any person or property owner of residential or commercial property within the Town boundaries to drill a private well, or connect to any existing water system, other than that of the system known as the “Alpine Water & Sewer District” which shall also be known hereinafter as “The Town Water System of Alpine, Wyoming”, except upon the approval of the Town Council or as provided within this Title 6.

Section II. Severability. If any section, subsection, or clause of this ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining chapters, sections, subsections and clauses shall not be affected.

Section IV. Conflicting Ordinances Repealed. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
