

The Town of Alpine passed the following Emergency Ordinance at the May 1st, 2007 Town Council Meeting.

155-Ordinance No. 2007-11
Town of Alpine

AN EMERGENCY ORDINANCE REALLOCATING FUNDS FROM THE TOWN OF ALPINE RESERVE FUND TO THE GENERAL STREETS AND ROADS FUND AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it has recently come to the Town Council's attention that there is insufficient money in the general fund to adequately maintain the streets and roads of the Town of Alpine; and

WHEREAS, the Town Council has been informed that sufficient funds exist within the reserve fund of the Town of Alpine to cover the costs of the necessary road maintenance; and

WHEREAS, the Town is responsible for the health, safety and welfare of its residents and has a responsibility to its citizens to provide safe and adequately maintained streets and roads; and

WHEREAS, pursuant to W.S. §16-4-114, the Town may make an expenditure of money in excess of the general fund budget in the event that an emergency exists; and

WHEREAS, due to the situation of the roads within the Town of Alpine, the Town Council has determined that an emergency exists.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL FOR THE TOWN OF ALPINE, WYOMING, THAT:

Section 1. That up to Fifty thousand dollars (\$50,000.00) is hereby reallocated from the Reserve Fund of the Town of Alpine to the General Fund of the Town of Alpine for street and road maintenance.

Section 2. Severability. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason to be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate distinct and independent provision and such holding shall not affect the validity of the remaining portions of the ordinance.

Section 3. Effective Date. This ordinance will be effective upon its passage as an emergency ordinance.

Passed as an emergency ordinance this 1st day of May, 2007.
