

164-ORDINANCE NO.2007-20

AN ORDINANCE ANNEXING CERTAIN REAL PROPERTY INTO THE CORPORATE LIMITS OF THE TOWN OF ALPINE; AMENDING THE CORPORATE LIMITS OF THE TOWN OF ALPINE, AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ALPINE, IN REGULAR SESSION DULY ASSEMBLED THAT:

SECTION I.

The Town Council of the Town of Alpine having initiated proceedings for the annexation of certain real property located adjacent to the corporate limits of the Town of Alpine pursuant to the terms and conditions of Wyoming Statute §15-1-404; and a public hearing being held on said annexation proceedings on the 18<sup>th</sup> day of December, 2007; and the Town Council having found that that the area considered for annexation complies with Wyoming Statute §15-1-402, the following property lying contiguous with and adjacent to the Town of Alpine, County of Lincoln, State of Wyoming, commonly known as that section of the Northbound lane of U.S. Highway 89 that passes through the Town of Alpine, said property being located within the SE1/4 of Section 30 and the SW1/4SW1/4 of Section 29, T37N R118W, Lincoln County, Wyoming, said land being more particularly described on Exhibit A attached hereto and made a part hereof by this reference is hereby added to, taken in and made a part of the Town of Alpine, Lincoln County, Wyoming.

SECTION II.

On the taking effect of this Ordinance, the corporate limits of the Town of Alpine and boundary lines thereof shall show and include the above-described property as being within the Town of Alpine.

SECTION III.

The Town Clerk of the Town of Alpine is hereby authorized and directed to file a certified copy hereof with the County Clerk of Lincoln County, Wyoming, and with the Secretary of State of the State of Wyoming.

SECTION IV.

This Ordinance shall take effect from and after the date of its publication following approval and adoption.
