AN ORDINANCE ADOPTING THE TOWN OF ALPINE BUDGET FOR FISCAL YEAR 2011/2012 BY THE TOWN OF ALPINE JUNE 30<sup>TH</sup>, 2011.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF ALPINE, LINCOLN COUNTY, WYOMING THAT 206 ORDINANCE NO. 2011-01 IS THE TRUE AND CORRECT ORDINANCE FOR THE FISCAL YEAR 2011/2012.
