

ORDINANCE NO 627

AN ORDINANCE OF THE TOWN OF MILLIKEN, WELD COUNTY, COLORADO ADOPTING BY REFERENCE ANNEXATION PROCEDURES AS PART OF THE MILLIKEN LAND USE CODE AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MILLIKEN, WELD COUNTY, COLORADO:

Section 1. Adoption

Pursuant to parts 1 and 2 of Article 16 of Title 31 C.R.S., the Annexation Procedures of the Town of Milliken is hereby adopted by reference as a portion of the Milliken Land Use Code. The subject matter of the Milliken Annexation Procedures establishes the regulations and process for annexation of property into the Town of Milliken. Three (3) copies of the Annexation Procedures of the Milliken Land Use Code are now filed in the office of the Clerk of the Town of Milliken, Colorado and may be inspected during regular business hours.

Section 2. Application

This ordinance shall apply to all annexation to the Town of Milliken, as well as the administrative procedures governing the submission of applications, and administrative and public reviews.

Section 3. Validity

If any part or parts of this ordinance are for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Trustees hereby declares that it would have passed this ordinance and each part or parts thereof, irrespective of the fact that any one part or parts be declared invalid.

Section 4. Repeal

Existing or parts of ordinances covering the same matters as embraced in this ordinance, specifically the current Article 13, Chapter 16 of the Milliken Land Use Code are hereby repealed and all ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this ordinance.

Section 5. Certification

The Town Clerk shall certify to the passage of this ordinance and make not less than three (3) copies of the adopted portion of the Code available for inspection by the public during regular business hours.

Section 6. Effective Date

At the regular meeting of the Board of Trustees of the Town of Milliken on August 11, 2010 this ordinance was introduced, and a public hearing held. Notice of the public hearing was published twice in a newspaper of general circulation in the Town of Milliken.


The Board of Trustees of the Town of Milliken herewith finds, determines and designates that this Ordinance shall take effect and be in force 30 days after publication.

The Ordinance was read, passed and ordered published by the Board of Trustees at its meeting this 11th day of August, 2010.


