

A RESOLUTION FOR THE ADOPTION OF REVISED LOCAL LIQUOR LICENSE FEES

WHEREAS, pursuant to the Colorado Department of Revenue Liquor Enforcement Division guidelines, the Town Clerk of the Town of Foxfield (the "Town Clerk") is authorized to collect liquor license fees for the State of Colorado and the Town of Foxfield;

WHEREAS, the Board desires to revise its Fee Schedule to conform to the Colorado Department of Revenue Liquor License Fee Schedule (the "State Fee Schedule"), attached hereto and incorporated herein by this reference as the same may be revised and updated from time to time without formal action of the Board of Trustees;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF FOXFIELD, COLORADO, AS FOLLOWS:

Section 1. The Board of Trustees sets the local licensing authority application fees as follows:


- (a) For any new license, one thousand dollars (\$1,000.00);
- (b) For a transfer of location or ownership, seven hundred fifty dollars (\$750.00);
- (c) For a renewal of license, one hundred dollars (\$100.00), except that an expired license renewal fee shall be five hundred dollars (\$500.00);
- (d) For the registration of a manager of a hotel/tavern who is separate from the licensed person or for a change in managers, seventy-five dollars (\$75.00)
- (e) The Town acting as the local licensing authority may charge corporate applicants and limited liability companies up to one hundred dollars (\$100.00) for the cost of each fingerprint analysis and background investigation undertaken to qualify new officers, directors, stockholders, members or managers; however, the local licensing authority shall not collect such a fee if the applicant has already undergone a background investigation and paid a fee to the state licensing authority.
- (f) For each retail liquor store license, twenty-two dollars and fifty cents (\$22.50) ;
- (g) For each liquor-licensed drugstore, twenty-two dollars and fifty cents (\$22.50);
- (h) For each beer and wine license, forty-eight dollars and seventy-five cents (\$48.75);
- (i) For each brew pub license, seventy-five dollars (\$75.00);
- (j) For each club license, forty-one dollars and 25 cents (\$41.25);
- (k) For each hotel, restaurant or tavern license, seventy-five dollars (\$75.00).

Section 3. The Town Clerk is further authorized and directed to revise the Fee Schedule from time to time to conform to the Colorado Department of Revenue Liquor License Fee Schedule as the same may be amended from time to time for local fees without further action of the Town Board of Trustees.




