Agreement

- By signing this agreement, the renting group's leaders and participants agree to abide by all facility policies and rules. Any breach of the rules or the rental agreement, illegal activity, or damages is cause for removal from the facility.
- When renting only the pool or the party room, this does not include use of the Flow Rider. The Flow Rider may remain open to the public, used for special events, or rented to a private group during the hours of the scheduled rental.
- **REFUNDS:** If weather prohibits (Thunder & Lightning) entry into the water before the rental starts, a full refund will be issued minus a \$25 administrative fee as long as the renter notifies the Pool Management within the first 15 min. If weather prohibits (Thunder & Lightning) entry into the water before the first half of rental concludes, a refund of 50% will be issued. After the first half of the rental, no refunds will be given.
- Lindon City is not responsible for any lost or stolen valuables. Children under 6 years of age must be accompanied by an adult at all times in the water. Children under the age of 3 must be wearing a swim diaper and plastic pants. They can be purchased at the window for a small fee.
- **Early entry into the facility may not be accommodated. Your rental times include setup and take down times.** The renter is responsible for all setup and takedown of outside equipment brought into the facility. Setting up of grills, B-B-Q equipment, soda fountains, cotton candy and/or catering company locations must be pre-approved by management and must not obstruct other pool operations. Inflatable rides and attractions must be pre-approved by management, require an extra \$50 fee, and require insurance naming Lindon City as additionally insured. Setup must be approved by the city. It is the responsibility of the renter to clean up any food and debris that is brought into the facility. Please place all trash in the trash cans and leave the facility clean.
- If renting the Flow Rider, each member of the group must have a signed waiver form. These can be printed off the website, or picked up before the rental. Any participant that does not have a waiver signed by themselves or a parent/guardian will not be allowed to ride the Flow Rider.
- Caterers are allowed in the facility, however early entry into the facility for set up will not be allowed during open swim.
- All fees must be paid in full at the time of the reservation. There will be a \$100.00 fee for cancellations.
- I understand the Policies of the Lindon City Aquatics Center and realize that I will be held liable while renting the facility. Should I breach this agreement, I shall pay all costs of damage, and/or attorney fees connected with the enforcement of this agreement.
