Mayor Weston called the meeting to order at 7:05 pm.

The floor was given to our guests from Evanston Regional Hospital for a presentation they had prepared on their facility. Mr. Winn informed us of the hospital's history, services it provides, physicians that are affiliated with the hospital, community involvement, and their plans for the future. They wanted to know if we would support their opening an office in our community. They asked if we knew of any building space available and if we felt it would be utilized. The office building owned by Bear Lake Physical Therapy was mentioned and they were given Kam Jarman's name to contact for that.

Several comments were made by the board. Scott said his insurance did not have Evanston as a preferred provider. It is Educator's Mutual through the school district which is a big employer in our county. The question was asked about pharmacy and laboratory services and how they would be handled. They were asked about employing local people in the office. All of these points would need to be worked out if the office became a reality. Dr. Broadbent says he has several patients now from the area and felt it would be worth it for him to come to them instead of them coming to him. The board agreed that we would certainly support any such asset to our community.

Our guests then left the meeting and Lana read the minutes from last month's meeting. They were moved to be approved by Scott with Brian seconding, approved unanimously.

The bills were read with Brian moving to approve them and Chris seconding, approved unanimously.

Lana announced to the board the success of the election turnout. It was approximately 67%, much high than most municipal elections.

OLD BUSINESS: The Mayor informed the board that the final cost for 480 conversion at the park well was \$6500. The board felt that this was something that would benefit our water system as well as our recreation program and should probably be done to upgrade our electrical supply.

Rocky Mountain power was also looking into providing us some assistance with planting the posts for our ballfield lights, we had no firm commitment on that as yet.

NEW BUSINESS: The Mayor asked if any of the board had any information on the BLM campground that also has the town's name on it. He was wondering if we could share in the fees charged to use it if we provided some maintenance during the months of heavy usage or scheduled reservations from our office. No one seemed to know, but suggested we ask former Mayor Kevin Kearl.

The town Christmas party on December 24 was discussed. We decided to use the same Santa as last year if he can come.

We have a donation from Rocky Mountain Power for \$300 for our Sub for Santa Program. This program is being run by a committee this year with DeeAnn Weston as Chairman. The 4-H Club is also doing a food drive for the holiday season.

We discussed days to deliver the Sub for Santa gifts and to sack the candy. Nothing was decided on for sure, due to the busy holiday season. We will discuss a firm date at the employee and elected official party on December 4.

Sim is working with Sunrise Engineering on the Sharon Weston water project and still hopes to get it in this fall.

There was nothing new to report on the animal shelter.

The board then went to the town office to canvass the election held on November 5, 2013. Lana asked the board their opinion on six provisional ballots. They decided not to count any of the six. The results were the same as previously counted and reported. Sim moved we approved the canvass of the election and Brian seconded.

Chris once again brought up the horse at Trujillo's. We have had no other complaints as of yet. Hopefully, they will find something to do with them soon.

Chris will also look into some decorations to add to our Christmas celebration this year.

Brian made the motion to dismiss the meeting at 8:45 pm and Sim seconded.
