

Heartstrings Talent Contest Rules

1. Fill out the entry form and send it with a photo of both aprons. Entries must be postmarked no later than June 1, 2013.
2. Entry garment will be judged on the best use of the pattern and fabric..
3. Contestants will arrive by 12:30 pm June 15, 2013, at the Sharonville Convention Center, 11355 Chester Road, Sharonville, OH, for space assignment and orientation.
4. The contest will begin on March 1, 2013. All contestants will need to use the Kwik Sew # K0103 Festive Kitchen Trio pattern or the Butterick See and Sew # B4585 pattern. These patterns will be available for sale at Sew-Ezy Sewing Studio 11427 Lebanon Rd Sharonville, Ohio 45241 513-563-7474 at a 20% discount
5. Fashion show will be Saturday, June 15 beginning at 1:30 pm, judging and announcement of winners will commence after the fashion show.
6. The Contest will take place under the supervision of Pam Folberth, Sew-Ezy Sewing Studio. Prize winners will be selected for the best use of Kwik Sew # K0103 or Butterick # B4585 creating both matching aprons for adult and child. Aprons are judged on the best use of the pattern and fabric. All entries must be properly labeled and the label secured to both matching aprons. Participants agree to be bound by these rules and the decision of the judges, whose decisions are final. All winners and qualifying finalist entries will be on display at the Sharonville Convention Center and will be on display until June 15, 2013, at 4 pm. Sponsors make no warranties with regard to the prizes. Prizes are not transferable. No prize substitution is allowed by the winner, but Sponsors reserve the right to substitute a prize of equal or greater value due to prize unavailability. Prizes are not redeemable by winner for cash value.
