QUILT ENTRY CRITERIA

Registration & Release of Liability Each exhibitor shall submit a registration form and photograph for each quilt submitted to Quilts on the Square & Beyond (QOSB). The photograph can be a simple snapshot as long as it shows the full quilt (no detail images are required). If possible, please also e-mail a digital photo to jhqf@stitchntimeinc.com. It is extremely important that the measurement of the quilt is exact as quilts will be hung in spaces where size is important (do not round measurements up or down). If the quilt is a different size than listed on the Quilt Entry Form, it may not be displayed. Each exhibitor must sign the Quilt Entry Form which includes a release of liability. It is understood that the exhibitor is the owner of the quilt being presented for display (if under the age of 18, a parent/guardian must sign the Quilt Entry Form). Quilt Entry Form, photograph and digital image must be received by midnight on July 31, 2014.

Insurance Insurance is the responsibility of the exhibitor. In the unlikely event that an entry is damaged, stolen or lost, Quilts on the Square & Beyond, Jackson Hole Quilt Festival and Stitch 'n Time, Inc. will not be held responsible.

Definition of Quilt A quilt is two layers of fabric with a filling that is stitched together by hand or machine. Quilts may not exceed 72" wide. We cannot accept stuffed animals, tablecloths, pillows, or other non-quilted items. No quilt may be entered that has been displayed in QOSB in previous years.

Labels & Sleeves All quilts shall have a 4" hanging sleeve and a label (preferably fabric) stitched to the back (another option for a label is to write in permanent marker on the sleeve). The quilt label shall include the quilter and/or owner name and contact information. This information should match the information on the registration form.

Sale Quilts QOSB will accept quilts for sale. Stitch 'n Time will handle all sales and retain a 30% commission. Good quality digital photos of the entire quilt are required (additional photos are encouraged to show details of the quilt). Digital photos shall be e-mailed in jpeg format to jhqf@stitchntimeinc.com by midnight July 31, 2014. Checks for sold quilts will be mailed no later than October 30, 2014. Quilts for sale must adhere to copyright law. Sold quilts must remain on display through the end of the quilt exhibit.

Photographs Quilt entries may be photographed during the festival, but photos may not be used for commercial purposes without the written consent of the exhibitor. Submission of a quilt to the QOSB constitutes consent by the exhibitor for it to be photographed and used by the Jackson Hole Quilt Festival and QOSB for promotional purposes.

Quilt Delivery Quilters will be notified on September 8 if their quilt is accepted. All quilts must be delivered to Stitch 'n Time, 955 Alpine Lane, Jackson, Wyoming between September 8 and 13, 2014. Any quilts delivered after September 15, 2014 will not be accepted. Quilts may be picked up October 16, 2014 at Stitch 'n Time.

Quilt Return by Shipping If quilter requests a quilt to be shipped back, a \$10.00 fee is required when the quilt is delivered in September. Quilts will be shipped no later than October 17.
