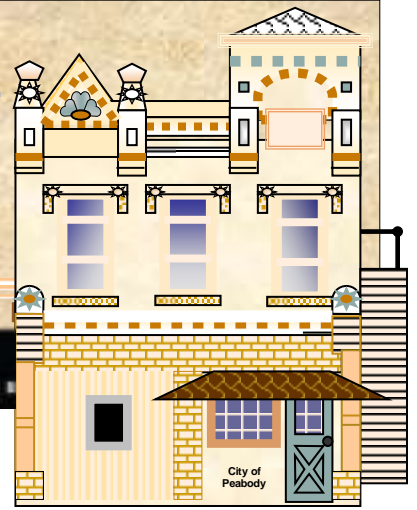

WATER PROBLEMS PROGRAM

City council meetings are open to the public. To get the most accurate and timely information, you are always invited to attend the meetings. When minutes of meetings are approved, they will become available to you free of charge for a time, at the front desk in city hall; minutes and agendas are posted to the city website; highlights of city council meetings will continue to be reported in the Peabody Gazette.

- City Offices will be closed Monday, January 2, 2017.
- Due to increased costs for trash and recycling services, City Council passed Ordinance NO. 10-2016 on December 12, 2016. The new charges which are effective with the December 28, 2016 utility bill are:
 - Residential trash service with a 95-gallon cart - \$10.84 per month
 - Residential trash service with a 65-gallon cart - \$10.34 per month
 - 2nd residential trash container - \$7.06 per month
 - Residential recycling service - \$3.13 per month
- 2017 trash/recycling calendar is included in this mailing.
- 2017 pet tags are now available. A late fee of \$15.00 will be charged for all pet tags issued after January 31, 2017.

IT IS ILLEGAL TO DUMP FURNITURE AND LUMBER AT OUR BURN PIT
The Kansas Department of Health & Environment requires that ONLY TREES AND BRUSH ARE PERMITTED TO ACCUMULATE AND BE BURNED AT THE BURN SITE. If this rule is broken we could all lose the benefit of having a city burn pit.
