1. Call to Order and Pledge of Allegiance

3. Adjourn to Meet as Local Building Authority

Council Member Dean Heavrin made the motion to adjourn to meet as the Local Building Authority. Steve McMahon seconded the motion. Motion passed with affirmative motions from Councilors Wahl, Martino, McMahon and Heavrin.

5. Council Member Steve McMahon asked about the plans for the facility. How long will it take to complete. Mayor Martino replied it should be completed in a year or less. Councilor McMahon inquired if the size was just for current needs or if it was planned for future needs. The mayor responded that the size planned for the future with the capacity to grow. It should take the Town into the future at least ten years. Councilor McMahon asked about staffing the facility. The mayor said the same assumptions were in play concerning staff.

Marc Edminster stated the CIB doesn't fund for current needs; they prefer the projects plan for the future. Mayor Martino agreed rather than being reactive, the Town tries to make provisions to deliver in the future. The facility will also take care of the equipment to prolong the service life.

Council Member McMahon indicated he would like to look at Staff on the next budget. He stressed the importance of taking necessary steps to retain valuable staff members.

The mayor commented when times are tight the Town tries to give other consideration to personnel.
